SITUATION

The Land at Orchard Farm is situated close to the village of Kirkmichael in South Ayrshire.

DESCRIPTION

The Land at Orchard Farm extends in total to approximately 49.37Ac (19.98 Ha) and is contained within one succinct block. Most of the land is graded by the James Hutton Institute as Grade 4(1) with a small area of Grade 5(3) and is used for grazing and silage purposes with cereal crops being grown historically. Within the 49.37 Ac, there is a small glen of amenity woodland extending to 2.05 Ac. The land is serviced by a mains water supply with the fencing a mix of post and wire with some stone dykes. The land is of good quality and it can be accessed from the public highway via a private track where there is a right of access marked A - B on the enclosed plan.

There will be maintenance obligations, on a user basis, in relation to the access track. Additional information is available from the selling agent.

METHOD OF SALE

The land is offered for sale as a whole.

The land is registered for IACS purposes. Entitlements are available by separate negotiation.


