# 1. Information and Scope of Inspection


This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description	The subjects comprise a detached cottage of traditional construction.
Accommodation	The accommodation can be summarised as follows: -
	Entrance Hall, Living Room, Kitchen, Utility Room, Three Bedrooms and Bathroom.
Gross Internal Floor Area (m²)	95
Neighbourhood and Location	The property is located a short distance to the south of Kinrossie, and enjoys a pleasant semi-rural location with open views over the neighbouring agricultural fields. Limited everyday amenities are provided within Balbeggie, with the area relying on Perth, 8 miles to the south for a wider range of facilities and essential services.
Age (Year Built)	1900
Weather	It was dry at the time of our inspection.







Chimney Stacks	There are multiple chimney stacks of traditional stone construction incorporating clay fired cans/pots. The flashings beneath are dressed with metal.
	Visually inspected with the aid of binoculars where appropriate.

# The roof is of pitched timber frame construction overlaid with slates and incorporates clay tile ridge component and metal dressed valley gutters. Access to the roof void was obtained via a ceiling hatch and fixed metal ladder. Insulation laid between the supporting joists restricted our inspection. Sloping roofs were visually inspected with the aid of binoculars where appropriate. Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.

Rainwater Fittings	The gutters and downpipes where seen are of cast iron installations and

Main Walls	The main walls are stone built. The rear projection is consistent with solid
	brick, although the internal walls appeared to have been insulated
	(Kingspan).
	Visually inspected with the aid of binoculars where appropriate.
	Foundations and concealed parts were not exposed or inspected.

Windows, External Doors and	The external doors are of timber panelled installations.
Joinery	With the exception of the bathroom, the windows are double glazed, and comprise of both timber sash and modern uPVC installations.  Internal and external doors were opened and closed where keys were available.  Random windows were opened and closed where possible.  Doors and windows were not forced open.
External Decorations	Elements of the external building fabric have a painted/preservative finish applied.
	Visually inspected.
Conservatories / Porches	There are no structures of this type pertaining to the subjects.
Communal Areas	There are no communal areas.
Garages and Permanent Outbuildings	There is a brick store shed accessed via a set of timber double doors. The roof is of pitched timber frame construction overlaid with corrugated metal sheets.  There are former kennels/dog run which were noted to be in a dilapidated condition and are considered to be beyond economical repair.

# **Outside Areas and Boundaries**

The property is afforded with private areas of garden ground, laid out to the front, sides and rear. The boundaries to the property comprise of post and wire fences and established hedgerow. Several of the boundaries were not physically defined on site, and the extent of the landholding and boundary positions will require to be confirmed through reference to the title information.

We understand that there are no rights of access over the grounds in favour of the neighbouring landowners and for the avoidance of doubt our valuation is provided on this basis.

# **Ceilings**

Plastered, with decorative surface finish.

Visually inspected from floor level.

# **Internal Walls**

Plastered, with decorative surface finishes.

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

# **Floors Including Sub-Floors**

The floors comprise of solid and suspended timber construction. Fitted floor coverings restricted our assessment.

Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.

Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.

Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch .



# The internal doors are of timber panelled installations, with internal joinery finishes including painted timber skirting boards and architraves. There is a fitted kitchen consisting a range of base/wall cabinets, worksurfaces and integrated appliances. Built-in cupboards were looked into but no stored items were moved. Kitchen units were visually inspected excluding appliances.

Chimney Breasts and Fireplaces	There is an open fire and decorative surround within the reception room.  Visually inspected. No testing of the flues or fittings was carried out.
Internal Decorations	Internal surfaces have a painted finish. There are tiled finishes within the kitchen and sanitary apartments.  Visually inspected.

Cellars	There are no cellars pertaining to the subjects.

Electricity	Mains electrical connection.
	Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or
	appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any
	services are turned off, the surveyor will state that in the report and will not turn them on.

Gas	There is no mains gas supplied.
	Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.



# Water, Plumbing and Bathroom Fittings

Mains connection, with plumbing where seen, noted to be run in PVC and copper.

There is a white fitted bathroom suite with an overhead electric shower.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

# **Heating and Hot Water**

Space heating is by means of an oil fired system. There is floor mounted conventional boiler within the kitchen and this feeds wall mounted radiators and towel rails.

There is an oil tank within grounds, the position of which is presumed to comply with the relevant guidance.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

# Drainage

Drainage we understand is to a private septic tank system. This was not inspected.

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

# Fire, Smoke and Burglar Alarms

Visually inspected. No tests whatsoever were carried out to the system or appliances.

New smoke alarm standards were introduced in Scotland in February 2022. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

# **Additional limits to Inspection**

Fitted floor coverings restricted our inspection and no hatch was located which allowed for an inspection of the sub-floor areas.

The services were not tested.

Insulation within the roof void was not lifted or disturbed, and accordingly our inspection of the timbers was compromised.

It is not within the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

Notes	There is evidence of movement having affected the building noted to both the internal and external fabric. This is however not inconsistent with a property of this type and age, and based on a single inspection is considered to be historic and longstanding in nature.

Notes	Elevated moisture readings were recorded to some lower level walls, timber floors and skirting boards, and with reference to these findings in conjunction with the age and type of property, it is recommended that a reputable timber and damp specialist contractor be employed to carry out a detailed inspection of the entire subjects prior to purchase.

	Chimney Stacks
Repair Category	2
Notes	Elevated moisture readings were recorded to the base of the right hand chimney stack, with stained/water damaged plaster noted to the bedroom walls beneath. These findings will require to investigated and repairs actioned as required.  Based on a limited external inspection, the chimney heads are weathered and some attention including pointing repairs will be required.

	Roofing including Roof Space
Repair Category	2
Notes	There are several displaced and chipped slates noted, and corrosion and patch repair to the metal components including the valley gutters. The roof is of a type and age which will require repair, and thereafter regular and careful attention, and it would be prudent to seek further advice from a reputable roofing contractor as to both the current condition and expected lifespan.  Damp stained timbers were noted throughout the roof void, consistent with both prior or intermittent leakage and condensation. Additional ventilation should be considered, and the affected timbers may require to be sprayed with a fungicidal treatment. It would be prudent to seek further advice from a reputable timber specialist contractor.

Notes	There is evidence of corrosion, leakage and patch repairs (which appear of a temporary nature). Attention is required where deterioration has occurred.

	Main Walls
Repair Category	1
Notes	The external walls are weathered, and some damage/deterioration was noted to several of the windows surrounds/sills. Some attention and pointing repairs will be required.

	Windows, External Doors and Joinery
Repair Category	2
Notes	The window within the front bedroom is cracked. The external frames show some evidence of wear and tear, with deterioration to the sill of the front bedroom window, and to areas of the fascia boards.  The replacement windows are of a type where periodic attention to the sealed units, hinges and other components should be allowed for as part of a normal programme of routine maintenance.

Notes	There are aspects of the external decoration which will require attention.

	Garages and Permanent Outbuildings

Notes	There is cut edge corrosion to the roof panels, woodborer beetle to the structural timbers and cracking to the floor slab. The store is considered to be fit for purpose however will require some attention and repair during a programme of normal decorative maintenance.  As referenced earlier, the kennels and associated dog runs, are in a dilapidated condition and are assumed to be beyond economical repair.

Notes	Several of the boundaries were not physically defined on site, and the extent of the landholding and boundary positions will require to be confirmed through reference to the title information.

Notes	Typical plaster blemishes were noted, consistent with age, and some normal decorative maintenance will be required.

	Internal Walls

Notes	Typical plaster blemishes were noted, consistent with age, and some normal decorative maintenance will be required.

	Floors including Sub-Floors
Repair Category	1
Notes	No significant defects were evident to the flooring at surface level, within the limitations imposed by fully fitted floor coverings.  It is not unusual to discover areas of past water spillage when floor coverings are removed in kitchen and bathroom compartments, revealing the need for further repair and maintenance work.
	No access to the sub-floor chamber was possible at the time of our visit to the property. Within the limitations of our inspection there was no indication to suggest significant defects in this area. It will, however be appreciated that the area was not inspected and therefore no garantees can be provided in this regard.

	Internal Joinery and Kitchen Fittings

Notes	The internal joinery was considered to have been maintained in a condition consistent with age and normal use with no significant defects noted. Some attention will be required through the course of normal decorative maintenance.

Notes	All flue linings should be checked, repaired if necessary and swept prior to the fires being reused.
	The former fireplaces to the bedroom accommodation have been removed, openings sealed and it should be ensured that the chimneys have been capped or vented as required.

Notes	The property appears in reasonable decorative order although it is recognised that on taking occupancy home owners may consider redecoration.

	Electricity
Repair Category	2
Notes	We were provided with an EICR from 2023 indicating that the electrical installation is satisfactory/safe. It does however indicate that installations are approximately 40 years old. Further upgrading may be required to comply with current electrical regulations and advice can be obtained from a reputable electrical contractor.  The Institution of Engineering and Technology recommends that inspections and testing are undertaken at least every ten years and on a change of occupancy. It should be appreciated that only the most recently constructed or re-wired properties will have installations which fully comply with IET regulations.

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.


Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

# **Estimated Reinstatement Cost for Insurance Purposes**

£475,000

It is assumed that insurance cover is obtainable on normal terms. The guidance figure is the estimate of costs for reinstating the subjects as at the date of inspection based on information provided by the Building Cost Information Service (BCIS). It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover. We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £475,000 (Four Hundred and Seventy Five Thousand Pounds Sterling).

# TERMS AND CONDITIONS OF SINGLE SURVEY

## **GENERAL**

# 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. \*

If the Surveyors have had a previous business relationship within the past two years with the Seller or Seller's agent or relative to the Property, they will be obliged to indicate this in the adjacent box. Yes

The Surveyors have a written complaints handling procedure. This is available from the offices of the Surveyors at the address stated.

# 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. The Report may give rise to a conflict of interest and if this is of concern to any party they are advised to seek their own independent advice.

The Report and any expressions or assessments in it are not intended as advice to the Seller or Purchaser or any other person in relation to an asking price or any other sales or marketing decisions.

The Report is based solely on the Property and is not to be relied upon in any manner whatsoever when considering the valuation or condition of any other property.

If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.

Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

# 1.3 Liability

The Report is prepared with the skill and care reasonably to be expected of a competent residential surveyor who is a member of the Royal Institution of Chartered Surveyors.

The Report is addressed to the Seller and is prepared in the expectation that it (or a complete copy) along with these Terms and Conditions (or a complete copy) would be (or, as the case might be, would have been) disclosed and delivered to:

- the Seller;
- any person(s) noting an interest in purchasing the Property from the Seller;
- any person(s) who make(s) (or on whose behalf is made) an offer to purchase the Property, whether or not that offer is accepted by the Seller;
- the Purchaser; and
- the professional advisors of any of these.



The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

### **DESCRIPTION OF THE REPORT**

### 2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

### 2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

Unless identified in the Report the Surveyor will assume that no harmful or hazardous materials have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

The Surveyor will not carry out an asbestos inspection, and will not be acting as an asbestos inspector in completing a Report of Property that may fall within the Control of Asbestos in the Workplace Regulations. In the case of flats it will be assumed that there is a duty holder, as defined in the Regulations and that a register of asbestos and effective management plan is in place, which does not require any expenditure, or pose a significant risk to health. No enquiry of the duty holder will be made.

# 2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. If certain minor matters are mentioned, it should not be interpreted that the Property is free of any other minor defects.

Throughout the Report the following repair categories will be used to give an overall opinion of the state of repair and condition of the Property:

# 2.3.1 Category 3:

# WARNING:

The Surveyor will collect physical data from the Property and provide such data in a format required by an accredited energy company. The Surveyor cannot of course accept liability for any advice given by the energy company.

# 2.7 Valuation & Conveyancer Issues

The last section of the Report contains matters considered relevant to the conveyancer (solicitor). It also contains the Surveyor's opinion both of the market value of the Property and of the re-instatement cost, as defined below.

"Market Value" is the estimated amount for which a property should exchange on the date of valuation within a willing buyer and willing seller in an arms-length transaction after proper marketing wherein the parties have each acted knowledgably, prudently and without compulsion. 

A valuation for mortgage is a limited inspection and report produced for building societies, banks and other lenders to enable them to make a lending decision. IT IS NOT A SURVEY. Unless otherwise stated the date of valuation will be the date of inspection.

This report is used to guide the lender on the market value of the Property for mortgage purposes and is carried out for this purpose alone. 



# The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use, CO<sub>2</sub> emissions, running costs and the savings possible from making improvements.

# The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 73 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 7.0 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 3.1 tonnes per year. # About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

# 1 Internal wall insulation

Internal wall insulation involves adding a layer of insulation to the inside surface of the external walls, which reduces heat loss and lowers fuel bills. As it is more expensive than cavity wall insulation it is only recommended for walls without a cavity, or where for technical reasons a cavity cannot be filled. Internal insulation, known as dry-lining, is where a layer of insulation is fixed to the inside surface of external walls; this type of insulation is best applied when rooms require redecorating. Further information can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk).

# 2 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work so it is best to check with your local authority building standards department.

# 3 Floor insulation (solid floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Insulating solid floors can present challenges; insulation laid on top of existing solid floors may impact on existing doors and finishes whilst lifting of a solid floor to insert insulation below will require consideration of the potential effect on both structural stability and damp proofing. It is advised to seek advice from a Chartered Structural Engineer or a registered Architect about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work and may also require a building warrant so it is best to check with your local authority building standards department.

# 4 Heating controls (room thermostat)

The heating system should have a room thermostat to enable the boiler to switch off when no heat is required. A competent heating engineer should be asked to do this work. Insist that the thermostat switches off the boiler as well as the pump and that the thermostatic radiator valve is removed from any radiator in the same room as the thermostat. Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

# 5 Condensing boiler

A condensing boiler is capable of much higher efficiencies than other types of boiler, meaning it will burn less fuel to heat this property. This improvement is most appropriate when the existing central heating boiler needs repair or replacement, however there may be exceptional circumstances making this impractical. Condensing boilers need a drain for the condensate which limits their location; remember this when considering remodelling the room containing the existing boiler even if the latter is to be retained for the time being (for example a kitchen makeover). Building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority building standards department and seek advice from a qualified heating engineer.

# 6 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

# 7 Wind turbine

A wind turbine provides electricity from wind energy. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Wind turbines are not suitable for all properties. The system's effectiveness depends on local wind speeds and the presence of nearby obstructions, and a site survey should be undertaken by an accredited installer. Planning permission might be required and building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for a wind turbine, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent).
