1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Neighbourhood and location	The subjects are located in a mainly rural area, approximately 2 miles
	to the northeast of Scone. There is a small number of residential
	properties within the neighbourhood although the surrounding area is
	mainly agricultural in character. Day to day amenities can be obtained
	from Scone in addition to Perth which is approximately 5 miles to the
	south.

Age (year built)	Circa 1900

Weather	It was dry at the time of inspection.

Chimney stacks	Visually inspected with the aid of binoculars where appropriate.
	Chimneys are of rendered brick construction and finished with metal flashings.

Roofing including roof space	Sloping roofs were visually inspected with the aid of binoculars where appropriate.
	Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.
	Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.
	The roof is predominantly timber pitched and overlaid in slates although there is a small flat linking section.
	Access to inspect the roof voids was obtained from a number of ceiling hatches at ground and first floor level. Insulation between and over supporting joists within each of the roof voids heavily restricted the inspection and no meaningful access was obtained beyond the hatches.

Rainwater fittings	Visually inspected with the aid of binoculars where appropriate.
	Gutters and downpipes are formed with PVC installations although a number of cast iron sections also remain.

Main walls	Visually inspected with the aid of binoculars where appropriate.
	Foundations and concealed parts were not exposed or inspected.
	The original walls are of traditional stone construction although an
	upper floor extension was added in the 1980s and is more consistent
	with brick/block. The single storey projection is also consistent with
	cavity brick/block and is understood to have cavity wall insulation
	(and internal insulation). The most recent wraparound extension has
	a load bearing inner timber frame with block outerleaf. The walls are
	mainly rendered/painted externally.

Windows, external doors and joinery	Internal and external doors were opened and closed where keys were available.
	Random windows were opened and closed where possible.
	Doors and windows were not forced open.
	Windows mainly comprise uPVC sealed unit double glazed installations typically installed within the last 10 years or so. A number of older PVC double glazed installations remain, mainly at the kitchen and older side projection. These are date marked from 1989. The main entrance is taken from composite double glazed double doors in addition to a number of PVC double glazed doors, patio doors from the living room and French doors from the main kitchen/family room.

External decorations	Visually inspected.

Conservatories / porches	Visually inspected.
	There is an open fronted sun porch/canopy consisting mainly of a timber frame set under a polycarbonate roof. There is a PVC double glazed side panel.
	There is also a similar area accessed from the family room. This is currently used for cats and no detailed inspection was undertaken.

Communal areas	There are no communal areas pertaining to the property.

Garages and permanent	Visually inspected.
outbuildings	There is a range of outbuildings pertaining to the property.
	There is a detached quadruple garage which is laid out as two double garages with four "up and over" vehicular access doors. The garage is of timber construction and these are set under a pitched and metal clad roof.
	There is a stone and slate workshop with automated roller shutter door. The workshop is located adjacent to the bio-mass boiler room and associated pellet store. There is also a detached stable block consisting of 6 boxes and a tack room.
	There is also a timber summer house and timber garden room currently used as a gym.

Outside areas and boundaries	Visually inspected.
	Access to the property is taken via a private surfaced drive leading south from Rait Road and this leads round to a parking area adjacent to the garages. There is also a gravelled area adjacent to the house accessed through a gate. There is a timber gated access to grounds adjacent to the stables also.
	There are areas of garden ground around the property in addition to a riding area and an adjoining paddock. In total, garden grounds are understood to extend to approximately 2.9 acres.

Ceilings	Visually inspected from floor level.
	Ceilings are consistent mainly with plasterboard although some lath and plaster sections may remain.

Internal walls	Visually inspected from floor level.
	Using a moisture meter, walls were randomly tested for dampness where considered appropriate.
	Internal walls are mainly finished with plasterboard. We were provided with photographs showing the installation of insulation boarding within the original parts of the property and also within the older side extension.

Floors including sub floors	Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.
	Sub-floor areas were inspected only to the extent visible from a readily accessible and unfixed hatch by way of an inverted "head and shoulders" inspection at the access point.
	Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.
	Flooring is mainly of suspended timber construction. Fitted floor coverings are present throughout restricting the inspection and no access was obtained to inspect any sub floor area.

Internal joinery and kitchen	Built-in cupboards were looked into but no stored items were moved.
fittings	Kitchen units were visually inspected excluding appliances.
	There is a fitted kitchen comprising floor and wall mounted units in addition to an island unit. Internal doors are mainly timber and there is a timber and carpeted internal stair.

Chimney breasts and fireplaces	Visually inspected. No testing of the flues or fittings was carried out.
	There are wood burning stove in the living room, kitchen and kitchen annex. These are partly flued through the adjoining chimneys in addition to a metal flue attached externally at the westmost chimney.

Internal decorations	Visually inspected.

Cellars	There is no cellar pertaining to the property.

Electricity	Accessible parts of the wiring were visually inspected without
	removing fittings. No tests whatsoever were carried out to the system
	or appliances. Visual inspection does not assess any services to make
	sure they work properly and efficiently and meet modern standards.
	If any services are turned off, the surveyor will state that in the report
	and will not turn them on.
	Mains electricity. The main consumer unit is located in a cupboard in the kitchen annex. This is supplemented by secondary distribution boards. These house circuit breakers.

Gas	Accessible parts of the system were visually inspected without
	removing fittings. No tests whatsoever were carried out to the system
	or appliances. Visual inspection does not assess any services to make
	sure they work properly and efficiently and meet modern standards.
	If any services are turned off, the surveyor will state that in the report
	and will not turn them on.
	There is a private gas supply.

Water, plumbing, bathroom	Accessible parts of the system were visually inspected without
fittings	removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.
	It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.
	Understood to be mains water. Visible plumbing is mainly copper and PVC. There are white fitted sanitary goods in the three WCs, the en-suite bathroom and the two en-suite shower rooms.

Heating and hot water	Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.
	There is a bio-mass central heating system served by a Windhager wood pellet fired boiler located within an outbuilding. This is distributed internally via radiators. It is understood that this is zoned to provide a separate system to the main house and annex. The central heating also provides the hot water supply in conjunction with a pre-insulated hot water tank located within the boot room.

Drainage	Drainage covers etc were not lifted.
	Neither drains nor drainage systems were tested.
	Drainage is to a septic tank located within the garden grounds. This was not checked/tested.

Fire, smoke and burglar alarms	Visually inspected. No tests whatsoever were carried out to the
	system or appliances. New smoke alarm standards were introduced in
	Scotland in February 2022 and it is likely that some properties may
	require additional works to meet these standards. In instances where
	alarms are in place, no tests whatsoever have been carried out and we
	cannot confirm if the system complies with the most recent
	regulations. Any potential purchaser should satisfy themselves as to
	whether the current system meets with regulations or otherwise.

Additional limits to inspection	The property was occupied at the time of inspection and there were contents, furniture and fitted floor coverings present throughout. No access was obtained to inspect any sub floor area and the inspection of the roof voids was heavily restricted due to the extent of insulation present and no meaningful access was obtained beyond the ceiling hatches. Only a limited view of the roof/chimneys could be obtained from ground level.
	It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.
	No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.
	It should be appreciated that the Home Report inspection is a non- disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

Sub floor ventilation is also restricted in areas and we were unable to establish underlying ground conditions. It would be advisable to have a timber and damp specialist carry out an inspection of the subjects to establish the full extent of repairs required and likely costs in this regard.

It would be prudent to ensure chimneys are checked and overhauled and maintained in a watertight condition. It would also be prudent to ensure the metal flue is appropriately installed.

Notes	The roof is of mixed age and complex in nature. The oldest single storey side projection is likely to be some 70 to 80 years old. There is wear and tear to slates in this area and corroded metalwork/holding straps. The main roof was constructed as part of the upper floor extension from around 40/50 years ago and the single storey side extension which is understood to have been completed around 2016. The roofs are generally considered to be in a condition consistent with age and type requiring a normal programme of maintenance. There is also a small area of rubberised flat roof and it should be appreciated that roof coverings of this nature do have a limited lifespan and can fail at any stage. Salting and staining was also evident as well as woodworm as previously stated.

4. Valuation and conveyance issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

Matters for a solicitor or licensed conveyancer

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include the most recent wraparound single storey extension completed around 2016. The older side projection is likely to date from the 1950s and the upper floor extension added in the 1980s. The garage was built around 2014.

It should be verified that all necessary registration documentation is available in connection with the septic tank.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Estimated reinstatement cost for insurance purposes

£950,000

The guidance figure is the estimate of costs for reinstating the subjects as at the date if inspection based on information provided by the Building Cost Information Service (BCIS). Building costs are currently increasing significantly above inflation due to increased demand and supply issues as a result of Brexit and the pandemic. It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover.

We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £950,000 (NINE HUNDRED AND FIFTY THOUSAND POUNDS STERLING).

TERMS AND CONDITIONS OF SINGLE SURVEY GENERAL

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. It is the responsibility of the Seller to ensure that the amended Report and Generic Mortgage Valuation Report are transmitted to every prospective Purchaser.

The individual Surveyor will be a member of the Royal Institution of Chartered Surveyors who is competent to survey, value and report upon residential property. *

1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. The Royal Institution of Chartered Surveyors rules require disclosure of any potential conflict of interest when acting for the Seller and the Purchaser in the same transaction. The Report may give rise to a conflict of interest and if this is of concern to any party they are advised to seek their own independent advice.

If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.



The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The impact of your home on the environment

Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 6 kg $CO_2/m^2/yr$.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. 1 Floor insulation (suspended floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Suspended floors can often be insulated from below but must have adequate ventilation to prevent dampness; seek advice about this if unsure. 4 Wind turbine
