1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Neighbourhood and Location	The subjects are situated in rural surroundings occupying an elevated position within the Breackachy area which itself lies approximately 4 miles west of Beaully. Immediate surrounding properties comprise scattered residential dwellings together with open croft land and countryside. There is a range of local amenities available within nearby Beaully and Muir of Ord whilst a wider range can be found within commuting distance of the city of Inverness which is situated approximately 15 miles east.

Chimney Stacks	There are chimney stacks of stone construction at the gable elevations. Visually inspected with the aid of binoculars where appropriate.

Roofing including Roof Space	<p>The main roof is of pitched design, clad with slates and incorporating tiled ridging.</p> <p>The roof over the single storey side projection is of pitched design and clad with profiled metal sheeting.</p> <p>The roof over the rear extension is of pitched design and clad with slates.</p> <p>The roof to the front WC projection is of Lean to design and clad with corrugated metal sheeting.</p> <p>There was no access gained to any roof void areas due to an absence of any access hatches.</p> <p>The ceilings are vaulted within the side projection although there is a storage area having been formed.</p> <p>Sloping roofs were visually inspected with the aid of binoculars where appropriate.</p> <p>Flat roofs were visually inspected from vantage points within the property and where safe and reasonable to do so from a 3m ladder externally.</p> <p>Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.</p>

Main Walls	<p>The main outer walls to both the one and a half storey part of the dwelling house and the single storey side projection are of solid stone construction, part pointed and part rendered externally.</p> <p>The rear extension walls are consistent with being of timber framed cavity concrete block and roughcasted type.</p> <p>The outer walls to the front WC projection are of basic, timber frame, timber clad type.</p> <p>Visually inspected with the aid of binoculars where appropriate. Foundations and concealed parts were not exposed or inspected.</p>

Outside Areas and Boundaries	<p>We understand from information provided that the total site area extends to approximately 2.5 acres or thereby. We would however emphasise that no site measurements were taken at the date of inspection and we have relied upon the site plan provided. It is understood that the immediate area of grounds surrounding the dwelling house extend to approximately 0.6 acres and has been decrofted with the remained being designated as croftland. The croftland itself is presently used for rough grazing purposes.</p> <p>There is a private driveway accessed off the main road subsequently leading to private off street car parking areas. The boundaries where seen are predominantly formed in post and wire fencing.</p> <p>There is a watercourse running through the front of the site.</p> <p>Visually inspected.</p>

Ceilings	<p>The ceilings are plasterboard lined.</p> <p>The ceiling areas are vaulted in the side projection.</p> <p>Visually inspected from floor level.</p>

Internal Walls	<p>The internal walls are plasterboard lined.</p> <p>Visually inspected from floor level.</p> <p>Using a moisture meter, walls were randomly tested for dampness where considered appropriate.</p>

Floors Including Sub-Floors	<p>The flooring at ground floor level is of solid concrete construction whilst the first floor is of suspended timber type. We would however emphasise that our inspection of floor surface areas was restricted due to the presence of fitted floor coverings and furnishings.</p> <p>Given the nature of construction there was no access gained to any sub floor areas.</p> <p>Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted.</p> <p>Physical access to the sub floor area may be taken if the Surveyor deems it is safe and reasonable to do so , and subject to a minimum clearance of 1m between the underside of floor joists and the solum as determined from the access hatch.</p>
Internal Joinery and Kitchen Fittings	<p>The internal skirtings and architraves are of painted timber finish whilst internal doors are of timber and timber/glazed type.</p> <p>The kitchen comprises a range of wall mounted cabinets and worktop surfaces.</p> <p>There is a timber staircase connecting the ground and first floors.</p> <p>Built-in cupboards were looked into but no stored items were moved.</p> <p>Kitchen units were visually inspected excluding appliances.</p>
Chimney Breasts and Fireplaces	<p>Some of the former fireplaces within the property appear to have been boarded over and no longer in use.</p> <p>There are modern stoves within both the living room and open plan kitchen/dining and study area.</p> <p>Visually inspected. No testing of the flues or fittings was carried out.</p>
Internal Decorations	<p>Internal decorations comprise painted finishes.</p> <p>Visually inspected.</p>

Electricity	<p>Mains supply. The electrical installation comprises 13 amp power points and the cable where visible is of pvc clad type. The electrical meter and consumer units is contained within a cupboard in the utility room.</p> <p>Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.</p>

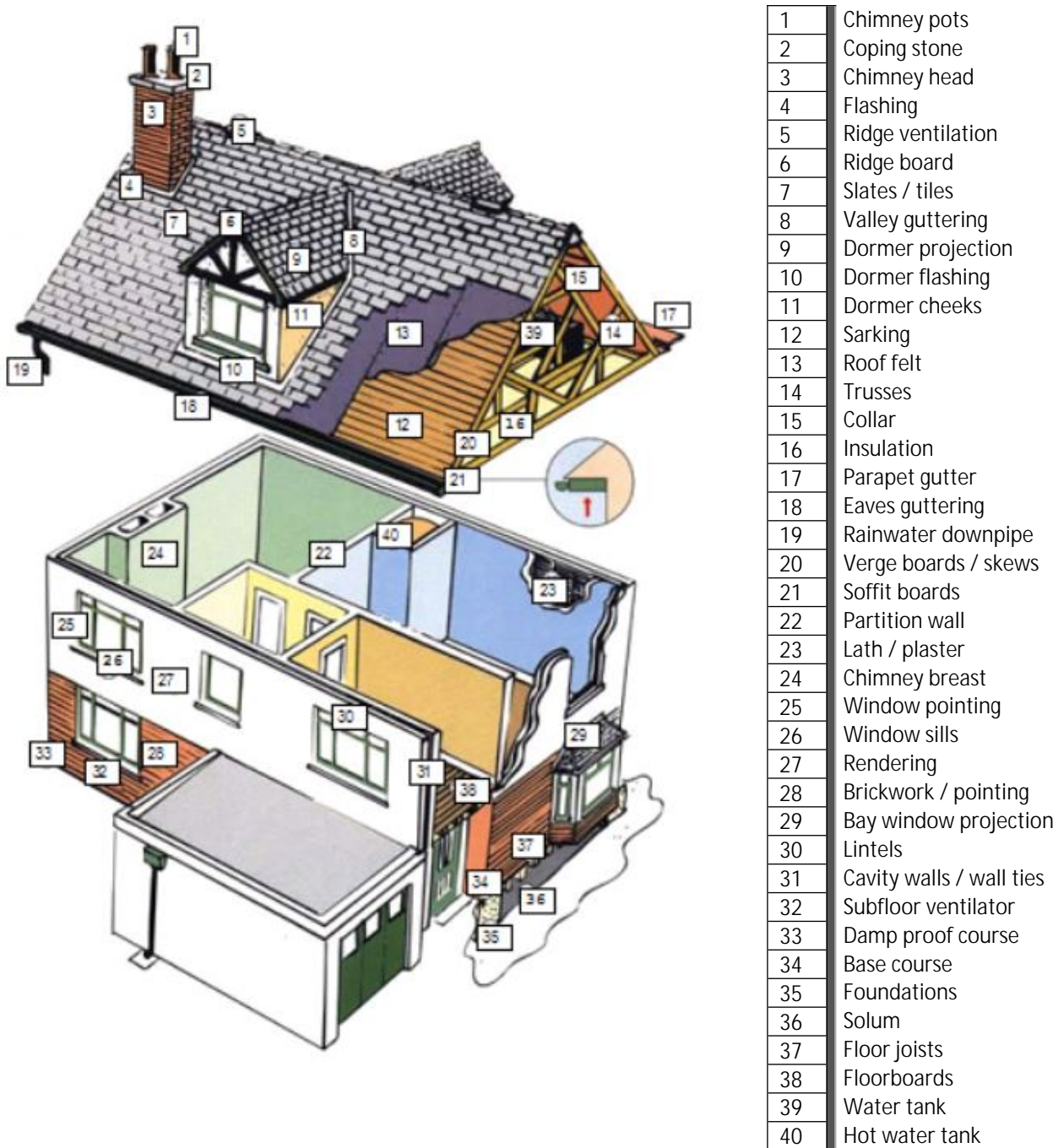

Water, Plumbing and Bathroom Fittings	<p>We understand that water is via a private supply.</p> <p>The sanitary fittings within the ground floor shower room and first floor bathroom are all of generally modern type. The ground floor shower room comprises a WC, wash hand basin and two separate showers in tray. The first floor bathroom comprises a three piece suite with there being a WC, wash hand basin and bath.</p> <p>There is a WC off the ground floor study area.</p> <p>Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.</p> <p>It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.</p>

Heating and Hot Water	<p>Fixed central heating is provided by an oil fired `VortexEco 15-21` external boiler which serves under floor heating at ground floor level. This also provides for domestic hot water which is supplemented by an electric immersion heater and contained within a pre insulated copper hot water cylinder which is within the utility room.</p> <p>Additional heating is via the stoves.</p> <p>There is an instantaneous hot water supply to the WC off the ground floor study.</p> <p>There is no form of fixed heating at first floor level.</p> <p>Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.</p>
Drainage	<p>We understand that drainage is via a private septic tank contained within the immediate garden grounds.</p> <p>Drainage covers etc were not lifted.</p> <p>Neither drains nor drainage systems were tested.</p>
Fire, Smoke and Burglar Alarms	<p>There appears to be a compliant smoke and heat alarm system within the property.</p> <p>Visually inspected.</p> <p>No tests whatsoever were carried out to the system or appliances.</p> <p>New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.</p>

Additional limits to Inspection	<p>At the date of inspection the property was furnished whilst the floors were covered.</p> <p>There was no access gained to any sub floor areas.</p> <p>Not all windows were tested during the course of our inspection.</p> <p>None of the services was tested during the course of our inspection.</p> <p>We would emphasise that only a limited inspection of the garden grounds/overall land was undertaken.</p> <p>It is outwith the scope of this inspection to determine whether or not asbestos based products are present within the property. Asbestos was widely used in the building industry until around 1999, when it became a banned substance. If you have any concerns you should engage the services of a qualified asbestos surveyor.</p> <p>No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.</p> <p>There was no access gained to any roof void areas.</p> <p>It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.</p>

4. Valuation and Conveyance Issues

This section highlights information that should be checked with a solicitor or licensed conveyancer. It also gives an opinion of market value and an estimated cost for insurance purposes.

Matters for a Solicitor or Licensed Conveyancer

The valuation is made on the assumption that any alterations that may have been carried out to the property satisfy all relevant legislation and have full certification where appropriate. While not necessarily an exhaustive list, alterations noted at the time of our inspection include the addition of the rear extensions and renovation of the overall property. We understand that the alterations were undertaken circa 1998 although we would recommend that full details be confirmed in this regard.

We are unaware of any adverse planning proposals affecting the subjects although this should be confirmed by obtaining a Property Enquiry Certificate.

Absolute Ownership assumed. We are unaware of any easements, servitudes or rights of way which may adversely affect the property. This point should be confirmed by reference to the Title Deeds.

We would recommend that the full extent of grounds pertaining to the property be confirmed by reference to the title.

We understand that the ground on which the main dwelling house is situated and immediate garden ground has been decrofted. However the remainder of the land is understood to be under crofting tenure. As such any prospective purchasers would require to be approved by The Crofters Commission. Our valuation provided below is based on the assumption that satisfactory acceptance from The Crofters Commission would be forthcoming from any future purchaser. We would recommend that full details be confirmed in this regard.

Drainage, we understand is to an exclusive septic tank which we understand lies within the feu. This was not checked or tested. It should be ensured that appropriate registration documents are available.

It is understood that there is a private water supply and it should be confirmed that the supply is fit for human consumption and the flow has been adequate and continuous for at least the last 10 years.

It is recommended that where repairs, defects or maintenance items have been identified, particularly categorised as a 2 or 3, interested parties make appropriate enquiries in order to satisfy themselves of potential costs and the extent of the works required prior to submitting a legal offer to purchase.

GENERAL

1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. Where the Surveyors are required to amend the valuation in consequence of such information, they will issue an amended Report and Generic Mortgage Valuation Report to the Seller. 1.2 The Report

The Surveyors will not provide an amended Report on the Property, except to correct factual inaccuracies.

The Report will identify the nature and source of information relied upon in its preparation.

The Surveyor shall provide a Market Value of the Property, unless the condition of the Property is such that it would be inappropriate to do so. A final decision on whether a loan will be granted rests with the Lender who may impose retentions in line with their lending criteria. The date of condition and value of the property will be the date of inspection.

Prior to the 1st of December 2008, Purchasers have normally obtained their own report from their chosen Surveyor. By contrast, a Report is instructed by the Seller and made available to all potential Purchasers in expectation that the successful Purchaser will have relied upon it. If certain minor matters are mentioned in the Report it should not be assumed that the Property is free of other minor defects.

Neither the whole nor any part of the Report may be published in any way, reproduced or distributed by any party other than the Seller, prospective Purchasers and the Purchaser and their respective professional advisors without the prior written consent of the Surveyors.

1.3 Liability

The Report is prepared with the skill and care reasonably to be expected of a competent residential surveyor who is a member of the Royal Institution of Chartered Surveyors.

The Report is addressed to the Seller and is prepared in the expectation that it (or a complete copy) along with these Terms and Conditions (or a complete copy) would be (or, as the case might be, would have been) disclosed and delivered to:

- the Seller;
- any person(s) noting an interest in purchasing the Property from the Seller;
- any person(s) who make(s) (or on whose behalf is made) an offer to purchase the Property, whether or not that offer is accepted by the Seller;
- the Purchaser; and
- the professional advisors of any of these.

The Surveyors acknowledge that their duty of skill and care in relation to the Report is owed to the Seller and to the Purchaser. The Surveyors accept no responsibility or liability whatsoever in relation to the Report to persons other than the Seller and the Purchaser. The Seller and Purchaser should be aware that if a Lender seeks to rely on this Report they do so at their own risk. In particular, the Surveyors accept no responsibility or liability whatsoever to any Lender in relation to the Report. Any such Lender relies upon the Report entirely at their own risk.

DESCRIPTION OF THE REPORT

2.1 The Service

The Single Survey is a Report by an independent Surveyor, prepared in an objective way regarding the condition and value of the Property on the day of the inspection, and who is a member of the Royal Institution of Chartered Surveyors. It includes an Energy Report as required by statute and this is in the format of the accredited energy company. In addition, the Surveyor has agreed to supply a generic Mortgage Valuation Report.

2.2 The Inspection

The inspection is a general surface examination of those parts of the Property which are accessible: in other words, **visible and readily available for examination from ground and floor levels without risk of causing damage to the Property or injury to the Surveyor.**

All references to visual inspection refer to an inspection from within the Property at floor level and from ground level within the site and adjoining public areas, without the need to move any obstructions. Any references to left or right are taken facing the front of the Property.

The inspection is carried out with the Seller's permission, without causing damage to the building or contents. Furniture, stored items and insulation are not moved.

2.3 The Report

The Report will be prepared by the Surveyor who carried out the Property inspection and will describe various aspects of the Property as defined by the headings of the Single Survey report with the comments being general and unbiased. The report on the location, style and condition of the Property will be concise and will be restricted to matters that could have a material affect upon value and will omit items that, in the Surveyor's opinion, are not significant. 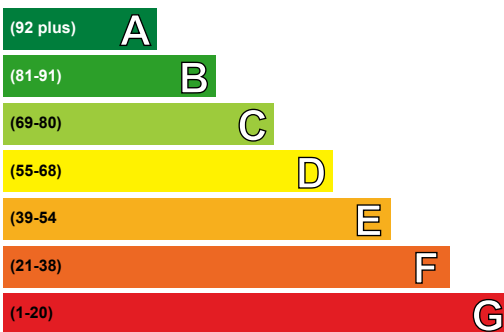

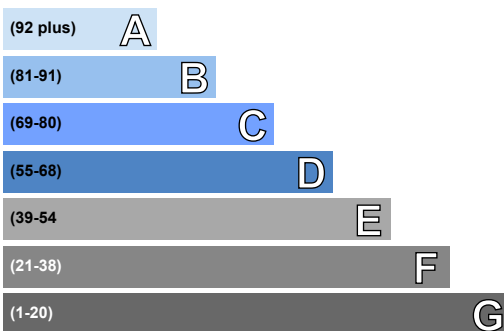

The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 75 kg CO₂/m²/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 12 tonnes of carbon dioxide every year. 

1 Room-in-roof insulation

Insulating roof rooms will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. If it has a flat ceiling insulation can usually be added above the ceiling, and sloping ceilings and walls of roof rooms can be insulated using an internal lining board. Roof voids must have adequate ventilation to prevent dampness; seek advice about this if unsure. Further information about roof room insulation and details of local contractors can be obtained from the National Insulation Association (www.nationalinsulationassociation.org.uk). Building regulations generally apply to this work so it is best to check this with your local authority building standards department.

2 Floor insulation (solid floor)

Insulation of a floor will significantly reduce heat loss; this will improve levels of comfort, reduce energy use and lower fuel bills. Insulating solid floors can present challenges; insulation laid on top of existing solid floors may impact on existing doors and finishes whilst lifting of a solid floor to insert insulation below will require consideration of the potential effect on both structural stability and damp proofing. It is advised to seek advice from a Chartered Structural Engineer or a registered Architect about this if unsure. Further information about floor insulation is available from many sources including www.energysavingtrust.org.uk/scotland/Insulation/Floor-insulation. Building regulations generally apply to this work and may also require a building warrant so it is best to check with your local authority building standards department.

3 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

4 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

5 Wind turbine

A wind turbine provides electricity from wind energy. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Wind turbines are not suitable for all properties.
