LOCATION

The Land at Kirkton Of Premnay is situated 2 miles south east of Insch, 8 miles west of Inverurie and 22 miles northwest of Aberdeen in a prime farming area.

DIRECTIONS

When travelling from Aberdeen take the A96 west from Craibstone roundabout. Continue for 17 miles before turning left at Oyne fork onto the B9002 signposted to Insch. Continue for 2.8 miles then left onto an unclassified road signposted Auchleven. Continue on this road for 1 mile then turn left down the farm track next to the bothy. The land will be found on the south side of the Gadie burn.

DESCRIPTION

The Land at Kirkton Of Premnay lies approximately 148 metres above sea level and extends to 145.02 acres (58.69 hectares). The land nestles in the foothills of the Bennachie range from which spectacular views can be enjoyed over the surrounding countryside especially from the peak known as the Mither Tap (518m above sea level). The majority of the land is currently in grass, being ring fenced for the containment of livestock. According to the James Hutton Institute the land is primarily classified as Grade 3(2), being capable of growing high yields of a wide variety of crops. The land lends itself to a variety of uses including agriculture, equestrian, forestry, or amenity. The Gadie burn to which livestock have access at waterings forms the march to the north of the land. In addition to the farmland, there is a derelict bothy adjacent to the public road which is suitable for conversion, subject to the relevant consents being obtained.


