# 1. Information and scope of inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description	The property comprises a substantial, one and a half storey detached villa with various outbuildings, set in approximately 12 acres of surrounding garden ground.
Accommodation	The accommodation may be summarised as follows:  Ground Floor - Inner Hall, Cloakroom WC, Bedroom 1 with walk-in wardrobe and En-Suite Bathroom, Living Room, Kitchen/Dining Area, Study, Utility area, Wet Room.  First Floor - Landing/Sitting room area, 3 Bedrooms (Two with En-Suite facilities), Shower Room.

# **Neighbourhood and location** The subjects are situated in rural surroundings, occupying an elevated position within the Drumbuie area on the eastern outskirts of Drumnadrochit. The property occupies an attractive position with panoramic views over Loch Ness, Drumnadrochit and beyond. Immediate surrounding properties comprise scattered residential dwellings, together with open surrounding countryside and croftland. There are a range of local village amenities available within nearby Drumnadrochit whilst a wider range can be found within commuting distance of Inverness. Age (year built) 2011 Weather Rain showers. **Chimney stacks** There is a chimney stack of roughcasted concrete block construction serving the stove within the Living Room/Kitchen area. Visually inspected with the aid of binoculars where appropriate. Roofing including roof space The roof is of pitched design, clad with concrete tiles and incorporating a tiled ridge. There was access gained to the accessible roof void area via a ceiling hatch in the first floor Landing area. Fibreglass insulation has been laid between the ceiling joists. Sloping roofs were visually inspected with the aid of binoculars where appropriate. Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so. The gutters and downpipes are of plastic manufacture. Rainwater fittings

# Garages and permanent outbuildings

There are a number of various outbuildings pertaining to the property. There is a former stable block of timber and corrugated iron construction which is currently being partly used as a store/workshop. In addition, there are also kennels and various wooden sheds/stores.

There is also a timber frame and corrugated onduline stable block located within the horse arena.

Visually inspected.

#### **Outside areas and boundaries**

We understand that there are substantial areas of ground pertaining to the property and from information provided, we understand that the total site area extends to approximately 12 acres or thereby. We would, however, emphasise we have not taken any site measurements and have relied upon the information provided. The grounds themselves are partly sloping in nature and the majority of which are presently used for rough grazing purposes. To the front of the dwellinghouse there is a outdoor carpet surfaced horse arena.

The boundaries, where seen, were formed in timber board and post and wire fencing.

Access to the subjects is initially via a long, rough surfaced private track which we understand lies out with the ownership, although we have been informed that a right of access exists over this and that any maintenance and upkeep is on a shared and equal basis.

Visually inspected.

#### Ceilings

The ceilings are plasterboard lined.

Visually inspected from floor level.

#### Internal walls

Internal walls are plasterboard lined.

Visually inspected from floor level.

Using a moisture meter, walls were randomly tested for dampness where considered appropriate.

# The flooring at ground floor level is of solid concrete construction, whilst the first floor is of suspended timber type. We would, however emphasise that our inspection of floor surface areas was greatly restricted due to the presence of fitted floor coverings and furnishings. Given the nature of construction, there were no sub-floor areas available for inspection. Surfaces of exposed floors were visually inspected. No carpets or floor coverings were lifted. Internal joinery and kitchen fittings The internal skirtings and architraves are of painted timber finish, whilst internal doors are of solid timber board type. The Kitchen comprise a range of wall mounted cabinets and worktop surfaces with an island feature.

#### **Electricity**

Mains supply. The electrical installation comprises 13 amp power points whilst the cable where visible is of PVC clad type.

The electrical consumer unit and meter is contained within a cupboard off the main Hallway.

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.

#### Gas

There is a bottled gas supply serving the property.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.

# Water, plumbing, bathroom fittings

Mains supply. The visible plumbing installation is in copper and plastic pipework where seen.

The sanitary fittings within the ground floor WC, En-Suite and first floor Bathroom and En-Suites are all of modern design.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

#### Heating and hot water

Fixed central heating is provided by an oil fired boiler which is located within a cupboard in the Wet Room at ground floor level and this serves underfloor heating at the ground floor and radiators to the first floor.

This also provides for domestic hot water which is supplemented by an electric immersion heater and contained within a modern preinsulated hot water cylinder which is within a Bedroom cupboard at the first floor level.

Additional heating is provided by the dual aspect stove at ground floor level.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

#### **Drainage**

We understand that drainage is via a private septic tank which we have been informed is located within the boundaries of the property.

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

## Fire, smoke and burglar alarms

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

#### **Additional limits to inspection**

At the date of inspection, the property was furnished whilst the floors were covered.

There was no access gained to any sub-floor areas.

Not all windows and doors were tested during the course of our inspection.

We have undertaken a limited site inspection only.

Insulation has been laid over the roof joists and accordingly a head and shoulders inspection of the roof space was possible only.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

Access was gained to some of the outbuildings only.

It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

# 4. Valuation and conveyance issues

We would recommend that the full extent of grounds pertaining to the property be ascertained by reference to the title.

Access to the subjects is initially via a private track. Confirmation should be obtained that a right of access exists over this and that any maintenance and upkeep is on a shared and equal basis with the neighbouring property. Full details should be confirmed.

## Estimated reinstatement cost for insurance purposes

#### £900,000

The guidance figure is the estimate of costs for reinstating the subjects as at the date if inspection based on information provided by the Building Cost Information Service (BCIS). Building costs are currently increasing significantly above inflation due to increased demand and supply issues as a result of Brexit and the pandemic. It is recommended that this figure is kept under regular review to ensure that you have adequate insurance cover.

We are of the opinion that the subjects should be insured for buildings reinstatement purposes for a sum of not less than £900,000 (NINE HUNDRED THOUSAND POUNDS STERLING).

#### Valuation and market comments

#### £750,000

We are of the opinion that the market value of the subjects all as previously described and on a vacant possession basis would be fairly stated in the region of £750,000 (SEVEN HUNDRED AND FIFTY THOUSAND POUNDS STERLING).

Our valuation reflects current market conditions relating to this area. We would assume that current trends will prevail at the ultimate date of disposal with no adverse or onerous matters being introduced into the market during the intervening period which would have a detrimental effect on price.

**GENERAL** 

#### 1.1 The Surveyors

The Seller has engaged the Surveyors to provide the Report and a Generic Mortgage Valuation Report for Lending Purposes. The Seller has also engaged the Surveyors to provide an Energy Report in the format prescribed by the accredited energy company.

The Surveyors are authorised to provide a transcript or retype of the Generic Mortgage Valuation Report on to Lender specific pro-forma. Transcript reports are commonly requested by brokers and lenders. The transcript report will be in the format required by the Lender but will contain the same information, inspection date and valuation figure as the Generic Mortgage Valuation Report and the Report. The Surveyors will decline any transcript request which requires the provision of information additional to the information in the Report and the Generic Mortgage Valuation Report until the Seller has conditionally accepted an offer to purchase made in writing.

Once the Seller has conditionally accepted an offer to purchase made in writing, the Lender or conveyancer may request that the Surveyors provide general comment on standard appropriate supplementary documentation. In the event of a significant amount of documentation being provided to the Surveyors, an additional fee may be incurred by the Purchaser. Any additional fee will be agreed in writing.

If information is provided to the Surveyors during the conveyancing process which materially affects the valuation stated in the Report and Generic Mortgage Valuation Report, the Surveyors reserve the right to reconsider the valuation. 




### **Energy Efficiency Rating**

## The energy efficiency rating of your home

Your Energy Efficiency Rating is calculated using the standard UK methodology, RdSAP. This calculates energy used for heating, hot water, lighting and ventilation and then applies fuel costs to that energy use to give an overall rating for your home. The rating is given on a scale of 1 to 100. Other than the cost of fuel for electrical appliances and for cooking, a building with a rating of 100 would cost almost nothing to run.

As we all use our homes in different ways, the energy rating is calculated using standard occupancy assumptions which may be different from the way you use it. The rating also uses national weather information to allow comparison between buildings in different parts of Scotland. However, to make information more relevant to your home, local weather data is used to calculate your energy use,  $CO_2$  emissions, running costs and the savings possible from making improvements.

## The impact of your home on the environment

One of the biggest contributors to global warming is carbon dioxide. The energy we use for heating, lighting and power in our homes produces over a quarter of the UK's carbon dioxide emissions. Different fuels produce different amounts of carbon dioxide for every kilowatt hour (kWh) of energy used. The Environmental Impact Rating of your home is calculated by applying these 'carbon factors' for the fuels you use to your overall energy use.

The calculated emissions for your home are 32 kg CO<sub>2</sub>/m<sup>2</sup>/yr.

The average Scottish household produces about 6 tonnes of carbon dioxide every year. Based on this assessment, heating and lighting this home currently produces approximately 9.3 tonnes of carbon dioxide every year. Adopting recommendations in this report can reduce emissions and protect the environment. If you were to install all of these recommendations this could reduce emissions by 3.0 tonnes per year. You could reduce emissions even more by switching to renewable energy sources.

## About the recommended measures to improve your home's performance rating

This section offers additional information and advice on the recommended improvement measures for your home

#### 1 Solar water heating

A solar water heating panel, usually fixed to the roof, uses the sun to pre-heat the hot water supply. This can significantly reduce the demand on the heating system to provide hot water and hence save fuel and money. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. You could be eligible for Renewable Heat Incentive payments which could appreciably increase the savings beyond those shown on your EPC, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

#### 2 Solar photovoltaic (PV) panels

A solar PV system is one which converts light directly into electricity via panels placed on the roof with no waste and no emissions. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Planning permission might be required, building regulations generally apply to this work and a building warrant may be required, so it is best to check with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for solar photovoltaic panels, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). Details of local MCS installers are available at www.microgenerationcertification.org.

#### 3 Wind turbine

A wind turbine provides electricity from wind energy. This electricity is used throughout the home in the same way as the electricity purchased from an energy supplier. Wind turbines are not suitable for all properties. The system's effectiveness depends on local wind speeds and the presence of nearby obstructions, and a site survey should be undertaken by an accredited installer. Planning permission might be required and building regulations generally apply to this work and a building warrant may be required, so it is best to check these with your local authority. The assessment does not include the effect of any Feed-in Tariff which could appreciably increase the savings that are shown on this EPC for a wind turbine, provided that both the product and the installer are certified by the Microgeneration Certification Scheme (or equivalent). ## Low and zero carbon energy sources

Low and zero carbon (LZC) energy sources are sources of energy that release either very little or no carbon dioxide into the atmosphere when they are used. Installing these sources may help reduce energy bills as well as cutting carbon.
